



Terms & Conditions

Cheers & Carts Ltd

- 1) **Deposit:** A non-refundable 50% deposit be paid to secure your booking and the date that you require.
 - 2) **Balance:** The remaining balance, along with the Damages Refundable Deposit (*see Term 5*), must be paid 7 days prior to the event. You will receive an email reminder closer to the event date.
 - 3) **Payment:** To be made by BACS to the account in the name of:
 - i. **CHEERS & CARTS LTD**
 - ii. Account no: 85183614 – Sort Code: 60-83-71
 - iii. Reference: Your Surname.

 - 4) **Price Change:** We reserve the right to increase the prices of our products at any time. If a 50% deposit has been made, we will honour the price agreed with you.
 - 5) **Damages Refundable Deposit:** We photograph the Cart, Glassware, and any accompanying decorations once they are set up at each event. We reserve the right to request an additional fully refundable deposit to cover any loss or accidental damage to our glassware and equipment during the event. The deposit amounts are as follows:
 - £100 for the Standard and Fancy Package Carts
 - £50 for the VIP Package Cart
- This deposit will be payable with the remaining balance 7 days prior to the event. If no damage is incurred, the full deposit will be refunded within 5 working days following the event. If damage is incurred, a proportional amount of the deposit will be refunded. If the cost of the damage exceeds the deposit amount, we reserve the right to charge an additional amount to cover the cost of repairing or replacing the damaged items.
- 6) **Cancellation:** The 50% deposit is non-refundable upon cancellation. If cancellation occurs after the remaining balance has been paid (7 days prior to the event), we reserve the right to not refund the balance payment.
 - 7) **Hire Times:** The hiring of the Cart and any accompanying decorations is for a maximum of 8 hours. If you wish to hire the Cart for longer than 8 hours, additional charges will apply, and this must be agreed upon prior to the event.
 - 8) **Delivery and Installation:** We will deliver, install, and collect the Cart free of charge within Bedford. We can deliver up to 50 miles for a small additional charge, which will be agreed upon prior to the event. We cannot be held liable for failure of delivery and installation due to events outside of our reasonable control.
 - 9) **Paperwork:** We hold a full public liability insurance certificate.
 - 10) **Venue Access** If we cannot access the venue to set up the Cart at the arranged time and must make additional trips to fulfil the booking, extra charges will apply.
 - 11) Cheers & Carts Ltd does not hold an alcohol licence; therefore, all alcoholic beverages must be provided by you. Upon request, we can provide non-alcoholic beverages.
